Structure, governance and management

The charity is a Charitable Incorporated Organisation (CIO) formed on 3 July 2018.

The trustees of the charity are appointed by the members at the AGM.

Objectives and activities

The charity's objects

To relieve poverty among families with young children, principally aged 0 to 4, and pregnant women, in conditions of need, hardship or distress within the Leeds area, for the public benefit, by:

- a) providing essential equipment and other items for children aged 0 to 4 and pregnant women.
- b) providing support through groups, drop-ins, events and projects benefitting the wider family.
- c) providing information on local agencies, charities or groups who may offer further support.

The charity's main activities

The Leeds Baby Bank provides pre-loved maternity, baby and toddler essentials to families in need across Leeds.

Public benefit statement

In setting our objectives and planning our activities our Trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular prevention or relief of poverty.

Achievements and performance

In 2019-2020 we provided baby essentials to families in need through a referral system, these referrals came to us via health care professionals such as midwives, health visitors, social workers, housing officers, children centre workers etc on average 15 referrals a week.

We rely on the general public in Leeds for the donation of preloved items such as cots, prams, clothes, baby bouncers, toys, baby monitors, breastpumps, bedding safety gates etc

Items such as mattresses, formula milk, feeding equipment etc needs to be new so money raised is used to buy these items.

In 19/20 we successfully applied for a number of grants that helped us buy these items and help with our running costs. We also fundraise on our social media platforms for items that we desperately need. Just before lockdown we had to close all of our donation drop off points to prevent potential spreading of Covid 19, this is resulting in our stock diminishing with difficulty to restock with preloved items.

As a result we had to close our regular referral form and have instead launched an emergency bundles form which has the basics such as nappies, wipes, formula, toddler food, and for many safety gates to ensure children's safety during lockdown. Working together with Leeds City Council we have 4 distribution points as well as our unit to get the support out quickly.

As you can imagine the needs for emergency support is incredibly high and this has impacted on our finances. Money raised has been used to purchase huge amounts of stock to keep up with the desperate need.

Financial review

The net receipts for the year were £4,207, all relating to unrestricted funds.

Reserves policy

The charity's free cash reserves at the year end were £14,160.

Reserves Policy trustees agreed upon. £1,000 only due to having very low overheads. This figure will be reviewed every three months as the charity becomes more established.
